## **I LOVE TRANSIT CAMP (KIDS) 2015**

### **How to Participate**

#### **DETAILS OF TRANSLINK'S I LOVE TRANSIT CAMP (KIDS) 2015**

TransLink's I Love Transit Camp (Kids) 2015 will be held on Tuesday, September 1<sup>st</sup>, 2015, for selected participants between the ages of 8 and 12 and their guardians. A total of 10 children and 10 parents/guardians (one parent/guardian per child) will be selected.

Selected participants and their parents/legal guardians will visit SkyTrain's Operations and Maintenance Centre (OMC) and Burnaby Transit Centre, and will travel on the SkyTrain to Burnaby Transit Centre. Selected participants will also have the opportunity to meet with bus operators and transit police officers. Further details will be provided to selected participants and their parents or legal guardians. There is no cost for the event and lunch will be provided.

#### **ELIGIBILITY**

To be eligible for TransLink's I Love Transit Camp (Kids) 2015, an individual must be:

- (a) between the ages of 8 and 12 as of September 1, 2015,
- (b) a legal resident of the Province of British Columbia, and
- (c) be accompanied by a parent or guardian at TransLink's I Love Transit Camp (Kids) 2015

Children of employees of the South Coast British Columbia Transportation Authority ("TransLink") and any of its subsidiaries are not eligible for TransLink's I Love Transit Camp (Kids) 2015. Also, participants of I Love Transit Kids Camp 2014 are also not eligible for TransLink's I Love Transit Camp (Kids) 2015.

#### **HOW TO PARTICIPATE**

To participate, entrants must submit a written piece (of 50 words or less) about what they love about transit. If desired, submissions can also include a photo or video to accompany the written piece. The photo or video must accompany the written submission and cannot be submitted separately.

All submissions must include:

- (a) the name, address, and phone number of the participant, how they heard about the camp, and

(b) the name, address, phone number and email address of the parent or legal guardian who will be attending TransLink's I Love Transit Camp (Kids) 2015 with the entrant, if selected.

Submissions received by any other method will not be accepted. Submissions must be received between August 12, 2015 and August 24, 2015. Early and late submissions will be rejected. Only one submission per entrant will be accepted; all subsequent submissions from the same entrant will be disqualified. The same parent or legal guardian may be listed for more than one entrant.

Each submission must be the property of the entrant. The parent/legal guardian, on behalf of the entrant, agrees to indemnify TransLink and its subsidiaries from any and all copyright, trademark or other intellectual property infringement claims or liability which may arise with regard to the entrant's submission.

Submissions must not include content that is unlawful, harmful, vulgar, obscene, hateful, discriminatory, or otherwise objectionable as determined by TransLink, in its sole discretion.

#### **SELECTION OF SUCCESSFUL SUBMISSION AND NOTIFICATION**

The winning entries will be chosen from all qualified entries on **August 25, 2015**.

The selected participants will be notified by TransLink within 48 hours of the selection via the telephone number provided by the entrant at the time of entry. A follow-up email will be sent to the parents/legal guardians of all selected participants with the I Love Transit Camp (Kids) 2015 Participant Form. Parents/legal guardians of the selected participants will be required to acknowledge via email receipt of the notification email. If no response is received by TransLink within two business days of notification, the application will be forfeited and an alternate entrant from the remaining eligible entries will be selected. The I Love Transit Camp (Kids) 2015 Participant Form must be completed and returned to TransLink no later than Friday, **August 28, 2015**.

#### **GENERAL TERMS AND CONDITIONS**

The odds of being selected are dependent upon the number of eligible entries received.

TransLink and its subsidiaries are not responsible or liable for any potential entrant's inability to access the submission process. TransLink and its subsidiaries are not responsible for lost, late, damaged, illegible, garbled, stolen, misdirected, misidentified, delayed, or incomplete submissions, for any problems or technical or mechanical malfunction of the computer online systems, servers, access providers, computer equipment, software, failure of any submission to be received by TransLink on account of technical problems or traffic congestion on the internet or at any website, or inaccurate entry information, whether caused by equipment, programming used in this contest, human processing or otherwise, or any combination thereof.
