

# **TRANSLINK SECRET SANTA CONTEST TERMS AND CONDITIONS**

PLEASE READ THESE TERMS AND CONDITIONS CAREFULLY. BY ENTERING THE TRANSLINK SECRET CONTEST (THE "CONTEST"), THE ENTRANT AGREES TO BE BOUND BY ALL THE TERMS AND CONDITIONS CONTAINED HEREIN. IF YOU DO NOT AGREE TO ALL OF THESE TERMS AND CONDITIONS, DO NOT ENTER THE CONTEST. FAILURE TO COMPLY WITH THESE TERMS AND CONDITIONS MAY RESULT IN DISQUALIFICATION AND/OR NULLIFY THE ENTRANT FROM PARTICIPATING IN THE CONTEST.

## **ELIGIBILITY AND PARTICIPATION**

To be eligible for the Contest, an individual must be (a) a legal resident of the Province of British Columbia, and (b) 19 years of age or older.

Employees of the South Coast British Columbia Transportation Authority ("TransLink"), its subsidiaries and its contractors, as well as family members of such employees, and household members who reside at the same address as such employees are not eligible for the Contest.

The Contest is void where prohibited by law.

## **SUBMISSION REQUIREMENTS AND CONTEST DEADLINES**

The Contest will open on November 26, 2014 at 9 a.m. Pacific Standard Time (PST) and all entries must be received by 11:59 p.m. PST on December 10, 2014. Late entries will be rejected.

To participate, entrants must visit the TransLink Buzzer Blog, click on the "TransLink Secret Santa" link and fill out the online entry form with the entrant's full legal name and daytime telephone number. The entrant must then, in the spaces provided:

- (a) nominate a deserving individual who regularly uses Coast Mountain Bus services or SkyTrain services to commute to and from work, school, community work or for other purposes to receive one of the monthly pass prizes described below; and
- (b) select the appropriate answers from the drop down menus provided; and
- (c) provide a short statement as to why that individual deserves to receive a monthly transit pass. THE NAME OF THE INDIVIDUAL SHOULD NOT BE PROVIDED; and
- (d) confirm that the nominee is expected to be travelling on Coast Mountain Bus services or SkyTrain bus services at least one day December 15 to 16, 2014, inclusive; and
- (e) confirm that the nominee is 19 years of age or older, and a legal resident of the Province of British Columbia.

Only one entry per person will be accepted; all subsequent entries will be disqualified. Entries received by any other method will not be accepted.

Each submission must be the property of the entrant. The entrant agrees to indemnify TransLink and its subsidiaries from any and all copyright, trademark or other intellectual property infringement claims or liability which may arise with regard to the entrant's submission.

Entries must not include content that is unlawful, harmful, vulgar, obscene, hateful, discriminatory, or otherwise objectionable as determined by TransLink, in its sole discretion.

Entries become the property of TransLink and will not be returned. By submitting an entry for the Contest, the entrant grants TransLink a non-exclusive, worldwide, royalty-free right in perpetuity to use and reproduce the entry in any manner without further permission or remuneration.

TransLink and its subsidiaries are not responsible or liable for any potential entrant's inability to access the submission process. TransLink and its subsidiaries are not responsible for lost, late, damaged, illegible, garbled, stolen, misdirected, misidentified, delayed, or incomplete entries, for any problems or technical or mechanical malfunction of the computer online systems, servers, access providers, computer equipment, software, failure of any entry to be received by TransLink on account of technical problems or traffic congestion on the internet or at any website, or inaccurate entry information, whether caused by equipment, programming used in this contest, human processing or otherwise, or any combination thereof.

## **PRIZES**

Qualified entries are eligible to win one of three three-zone monthly transit passes.

All prizes will be awarded to the nominee. The qualified entrant does not win any prize.

## **SELECTION OF WINNING ENTRIES AND WINNER NOTIFICATION**

All complete entries received by the contest deadline will be judged against the following

- How often does the nominee ride transit: Daily (2 points)/Weekly (1 point)/ monthly (0 point)
- Does the nominee volunteer in the community: Yes (1 point)/ No (0 point)
- Has the nominee made a difference in your life: Yes (1 point)/No (0 point)
- Has the nominee inspired you to be better: Yes (1 point)/No (0 point)
- Why does the nominee deserve a free Monthly FareCard (open text): 6 points based on traits of integrity, honesty, sincerity, honourableness, kindness and influence as demonstrated from the free text comments provided. 1 point for each trait, maximum 6 points

The winning entries will be chosen randomly from the qualified entries scoring all 11 points on December 11, 2014. In the event that fewer than three entries receive a score of 11, qualified entries receiving a score of 11 will be selected as winners, and the remaining winning entries will be chosen randomly from qualified entries scoring 10 points.

The selected winners will be notified by TransLink within 48 hours of the draw via the phone number given by the entrant at the time of entry.

The selected winners will be required to acknowledge via phone his/her receipt of the notification of eligibility for the prize. If no response is received by TransLink within one (1) business day of initial notification, the prize will be forfeited and an alternate winner from the remaining eligible entries will be selected. Up to two redraws will be made for each gift certificate prize.

To be declared a winner:

- (a) the selected winner must first correctly answer, unaided, a time-limited, mathematical skill-testing question; and
- (b) the selected winner must sign a release, in a form acceptable to TransLink, which will include an agreement to gift the prize to the nominee and to participate in the gift exchange at the time and place to be determined, including videotaping of the gift exchange; and
